1. **Eligibility:** The Ultimate Blog Party **Scrubbing Bubbles Giveaway** ("Sweepstakes") is open only to legal residents of the fifty (50) United States (including the District of Columbia) and Canada (excluding Quebec) who are at least eighteen (18) years of age.
